Joint Meeting with the City of Burlington: We are all set for 9/23 at 4pm, SCC at the Private Dining Room just of the student dining area at the cafeteria.

- **STBG:** SEIRPC STBG & TAP funding letter and scoring attached.
- **Mt. Pleasant Street & Beaverdale Intersection:** Attached are the current estimates for signal and camera improvements for the TSIP grant for this intersection.
- **IISC:** Looks like we will have the following engineering projects for the Fall. Hoping for more projects in the Spring when they typically have larger class sizes:
 - Agency Street Trail - WB Ave to Gear.
 - Likely Broadway Trail to Rec Plex as well
 - Agency and Broadway Intersection (Perhaps Gear and Agency recommendations and Gear ((Mall to West side of street) if they can fit it in - at least some recommendations).
 - Luers Park Stormwater Projects/Designs
 - Housing Subdivision - Deery Property (Layout, utilities, roads, etc.)
- **Sunset Subdivision:** Council discussion September 4, 2024. Again, I noted that the city indicated that it was capable of providing sanitary sewer to the Sunset area during the 1975-1979 annexation proceedings. It did not commit to doing so. The city contemplated using taxes (levy rate), GO bonds, and noted that they often use special assessments for projects. More to come...
- **Comp Plan & Zoning:** Mojra Hauenstein with Bolten & Menk will be taking over as project manager for these efforts. Ed returned to the academic world. Mojra was going to be the original lead and a short bio is attached. I think you will see her up to speed rapidly. We have a plan to continue forward. The other team members are still part of the team. This is the team member I had originally planned to be working with and think you will like her approach and the results. Good call today with Jim and Mojra.
